LIFE AND INDIVIDUAL ASSOCIATES - CRITERIA AND CONDITIONS

- 2101 Any person over the age of 16 who wishes to show support for the Game in Hampshire may be admitted as a Life Associate, subject to payment of the current Life Subscription, or an Individual Associate, subject to payment of an initial current subscription and annually thereafter payable by standing order on 1st October each year.
- 2102 An Application Form and Standing Order are below; please print and on completion please send to the County Office.
- 2103 All Life Associates and Individual Associates (provided always that the annual subscription has been paid by the due date) will receive the following privileges
- 1 A copy of the Annual Handbook via the website – a PDF copy online.
 - 2 A copy of the Annual Report via the website – a PDF copy online.
 - 3 The right to apply each year for tickets for Home International Matches involving England at Twickenham, or at any other venue which may be decided by the RFU. The opportunity to apply for tickets for Away Matches in the Six Nations is very limited as few tickets are allocated to this Union.
 - 4 The opportunity to apply for other tickets as notified by e-mail to those for whom an e-address is held.
 - 5 Free admission to all County matches.
 - 6 The opportunity to purchase a County Member's Tie.
- 2104 An Individual Associate shall cease to be eligible to receive the privileges specified if the annual subscription is not fully paid by 31 December.
- 2105 An Associate who has purchased an international ticket must be able prove that they have used the ticket by retaining it for a period of three months. If a ticket is passed on to a member of the family or a friend then the Associate must ensure that the recipient retains the ticket as it may be required if an investigation is instigated. An Associate who is unable to produce a ticket when requested by the Ticket Officer will be considered to have committed a willful breach of Hampshire RFU's conditions of issue and will almost certainly be denied the privilege at **2103.3** for a specific period, subject always to appeal to the Executive Director.
